



Government Initiatives

Urban Development and Municipal Affairs

CREDAI Bengal has been in constant dialogue with the Urban Development and Municipal Affairs Department (UD & MA), Government of West Bengal to resolve the issue of levy of exorbitant charges for grant of additional FAR in New Town Planning Area. Accordingly we've recently written to the UD Department for the requisite notification based on the outcome of the joint meeting held under the aegis of the Joint Secretary. The matter will be brought in our forthcoming meeting with the Principal Secretary, UD and MA Department.

Environment Department

- a. Based on our continued follow-ups with the Environment Department, we hereby inform you that the Checklist for grant of Environmental Clearance has finally been published vide notification no. 3435/ENT/T-II-1/011/2018, dated 30.10.2018.
- b. The senior members of CREDAI Bengal had also met Shri Indevar Pandey, IAS, Additional Chief Secretary (ACS), Department of Environment, and as per discussion a letter addressing the issue as to whose favor the Environmental Clearance should be issued in case of properties having multiple ownerships, was submitted along with a draft undertaking by which the developer would remain liable for all compliances. This is currently under consideration.
- c. As per the new MoEF&CC notification dated 14.11.2018 and 15.11.2018 no prior environmental clearance will be required for large housing projects with built up area >20,000 sqmt upto 50,000 sqmt. The local authorities can now grant environmental clearance to projects of above kind after ensuring that the projects comply with the stipulated environmental conditions.

Microwave

a. The long pending issues of obtaining clearance from Microwave was partially resolved for all non-core areas. Now, permission for height is being obtained within a very short span of time. CREDAI Bengal is currently putting an effort to resolve the issues in rest of the affected areas by Microwave.

Skilling, Labour Registration

Skilling:

CREDAI Bengal's on-site skilling is in process and we've finished five batches at Merlin 5th Avenue, Sugam Habitat and Siddha Galaxia where 134 workers got enrolled and 91 workers completed their skill training. More candidates for enrolment are being scouted for at these sites to skill them in Masonry, Bar-Bending and Carpentry trades. Currenty, talks are on with DTC Group, Rungta Group and Shapoor-ji Pallonji to start skilling training programmes. More awareness is being created amongst the developers for the need to skill workers to meet the long term requirements of the industry.

Labor Registration:

New features of Labor Registration under SSY 2017:

- On-line registration
- No need for officials to visit a site
- Registration can be done from the site office or the contractor's office

Appeal:

All contractors should enable their workers to be registered with the BOCW Welfare Board enabling them to draw relevant benefits as and when required. The CREDAI Bengal Youth Wing has now taken up worker registration as a thrust area to contact more developers and contractors to engage in worker-registration initiatives.

Action Plan

- 1. We are creating awareness amongst our member developers and their contractors for registration of their workers.
- 2. The Secretariat is in touch with the Labour Dept. to learn about the on-line approach and training and assisting the Developers to implement the same at project sites.
- 3. PS Group has already taken the initiative of registering their workers and started the same at their projects 'The Reserve' and 'Aurus'.
- 4. CREDAI Bengal has also spoken to Unimark, Merlin, Siddha and Rishi Group to create awareness and interest. Registrations will start soon.

Job Fair by PBSSD, 26th and 27th November, 2018

The State Government is going to organize a Job fair on the 26th and 27th of November, 2018. In this context CREDAI Bengal has been requested by Dr. Amit Mitra, Honorable Finance Minister, Government of West Bengal, to communicate to all CREDAI Bengal members seeking their active participation in the Job Fair to be conducted by the Government of West Bengal.

The basic objective of the Job fair would be to hand over appointment letters to 10,000 candidates having vocational training qualification at Secondary and Higher Secondary level, diplomas/certificates from ITIs and Polytechnics covering different disciplines and trades such as IT & ITES, construction, mining, hospitality etc. CREDAI Bengal has been given a target for recruitment of 200 such candidates in the concerned disciplines/trades.

CREDAI Bengal Secretariat has also attended 3 meetings organized by the Department of Skill development (Govt. of West Bengal) as of now. The first meeting was held on 11th October at Nabanna, where the Honorable Finance Minister Dr. Amit Mitra and Skill Development Minister Shri. Purnendu Basu were present. We have also attended two other meetings regarding the same, chaired by the Principal Secretary, (Skill Development) Smt. Roshni Sen. CREDAI Bengal will have an active participation at the PBSSD Job fair on 26th & 27th November at Netaji Indore Stadium where we will also have our own stall to showcase how CREDAI Bengal is active across the state regarding Skill development. We would also like to project our member developers who have shown keen interest for the Job fair. So far, the following members have confirmed that they would recruit from the said job fair. We look forward to scheduling the interviews at the earliest prior to the event.

Statement by National President



Beginning of a new relationship between CREDAI Bengal and The Heritage Group of Institutions





'RETAIN FACADE OF BLDGS, DEVELOP REST OF PLOT'

Kolkata: The West Bengal Heritage Commission is set to place a radical proposal before the Kolkata Municipal Corporation that it believes will help save the city's architectural fabric and character while allowing modern development.

"Kolkata is a city rich in character due to the diversity of its people and built heritage. When an architecturally and aesthetically significant building that has been an integral part of a neighbourhood for decades disappears, we lose a bit of the city. What we plan to propose to the municipal commissioner is that the skin of these buildings be retained and development allowed in the rest of the plot. We also suggest that the development be a glass and steel building or any other type of backdrop building that does not interfere with the architecture of the original building," state heritage commissioner member

SAVING HERITAGE

- > Proposal to retain skin of facade of interesting buildings while allowing construction in the plot behind without reducing FAR for the section of old building that is left standing
- New building should be made of glass and steel or in a style that is in contrast to the

original building; it should preferably act as a backdrop rather than draw viewers' attention to itself

➤ Heritage buildings should be strengthened and made fit for adaptive reuse by putting in place provisions for cables, air-conditioning and fire-fighting system

and conservation architect Partha Ranjan Das said.

Das has, in fact, suggested such a development in a building that currently houses the Indian Medical Association on Lenin Sarani and has even offered to do a rendition of development for free to push the cause.

There have been some developments along these lines in Kolkata. On Pretoria Street, the Aspiration group has done such a development called Vintage Pretoria where the facade of the old building has been retained and a glass building developed behind it. It is currently engaged in another such development on Shakespeare Sarani while PS Group has also done a similar project on Loudon Street-Theatre Road intersection. Even Diamond Heritage,

the steel and glass office building behind the Mackinnon Mackenzie building facade in Dalhousie is another example. The Srijan group has restored a house on Elgin Road but the development it has done behind it closely follows the original building's architectural style.

"There is no clash between conserving heritage and creating something modern. We must not copy old features in new buildings like it has happened in Calcutta high court. That is very sad. Architects and developers need to raise the level of awareness on how to combine the old and the new," said Das.

Developer Nandu Belant. chairman of the Bengal chapter of Real Estate Developers Association of India (Credal), says heritage and environment are the twin challenges before the city that the civic authority. developers and architects need to tackle jointly "The government and KMC has to play a positive role by making changes in the tenancy law and relax development rules so that buildings that have character but aren't identified as heritage can be retained wholly or partly in the latter case, if the facade is retained, it should not lead to loss of FAR for the developer. On the contrary, there should be an incentive to drive developers to retain old buildings," he said.


