## CIRCULAR NO. 09 of 2020-2021

Phase wise Implementation of Common Application Form (CAF) under Ease of Doing Business in Construction Permit for Online sanction of Building Plan u/s 393A of the Kolkata Municipal Corporation Act 1980

It may be noted that Common Application Form (CAF) for online sanction of Building plan through a single window system under EoDB in Construction Permit has been launched.

In order to implement the EoDB system to deal the applications under section 393A of the KMC Act 1980, CAF system will be introduced in a phased manner as described below:
